VI. Public Hearing to Discuss Alpine ISD's Every Student Succeeds Act (ESSA) 2020-2021 Grant Application (Goals 1, 2)

Presenter: Caroline Fox - Director of Curriculum and Special Programs

Board President Eddie Natera convened Public Hearing at 5:35 p.m.

Caroline Fox reviewed the purpose of the ESSA Grant, eligible programs, and amounts to be allocated from the grant.

VIII. Review and Consideration of Approval of Value Engineering Item Number 10 - Air Handler Units with duct socks in lieu Air Rotation Units -- Locations - High School Gym, Middle School Gym, Elementary Gym. For a Cost Savings of \$110,562 (Goals 2, 4)

Presenter: Parkhill, Smith, and Cooper, LLC

Les Burke presented information on the Value Engineering Item Number 10 – Air Handler Units. Utilization of these units in the three main gyms would result in a savings of approximately \$110,562.00

A motion was made by Mary McCallister, seconded by Joe Portillo, to approve of Value Engineering Item Number 10 - Air Handler Units with duct socks in lieu of Air Rotation Units for the High School Gym, Middle School Gym, and Elementary Gym, at a cost savings of \$110,562.

Justin Gonzales, AHS Principal, reported on progress on testing dates and number of students being tested for the SAT, PSAT, and ASVAB. He also reported that CTE teachers have been meeting to align courses and certifications.

A. Chief Financial Officer

Presenter: Tucker Durham

1. Monthly Report

Tucker Durham reviewed the tax collections and financials for the month of September, 2020.

2. Discussion of Financial Topics

Mr. Durham provided the Board information on two grants received from the Office of the Governor, in the amounts of \$113,000 and \$58,000. Additionally, he explained that the District has received information that TEA will extend the "hold harmless" process for ADA through the end of the first semester, as opposed to using true ADA.

XV. Discussion of Property Values (Goal 2)

Mr. Durham provided information received from Karla Pope-Osborne with Perdue, Brandon, Fielder, Collins, and Mott, delinquent tax attorneys for Alpine ISD. Ms. Pope-Osborne had compiled information on property value studies dating back to 2014, and the problems with County appraisals and the data being provided. Mr. Durham reviewed the data on worksheets and differences between CAD values and State values and how it impacts funding for Alpine ISD.

Ms. McCutchen reviewed the current status of enrollment, attendance, and gaps in learning under the current synchronous and asynchronous remote learning. Principals were then given an opportunity to share information from teachers, preferences, problems, and concerns about the process.

A motion was made by Adrian Billings, seconded by Mary McCallister, to approve Ms. McCutchen's recommendation to limit synchronous and asynchronous instruction for students, as of October 30, 2020, with great thanks being given to the teachers, staff, and administration who have worked diligently to make these processes work.
